The colloquium will provide a space for intellectual exchange and constructive feedback. It also aims to establish a regional network of researchers, promoting sustained dialogue, collaborative research, knowledge exchange, and professional development in the field.

Edited Volume: Activism in Exile – Reimagining Agency and Protection in an Era of Crisis

Jun-Prof. Figari Layús and Prof. Paul Gready from the CAHR (Centre for Applied Human Rights, University of York) are preparing an edited volume and asking for contributions.

Multiple contemporary crises – populism, conflicts, shrinking civic space, climate change, austerity – are combining to push more and more human rights defenders and activists into exile.

This edited volume seeks to address a gap in academic literature on activism in exile and protection infrastructures in the contemporary polarised political context. The focus is not exclusively on universities as sites of agency and protection, but we welcome contributions on universities. We invite contributions that examine the agency of activists in exile, the architectures of protection that shape their possibilities, and the evolving and different roles and different modalities of intervention of universities in these dynamics. Contributions on any countries, regions or cases are welcome.

Deadline for proposals (300–500 words): **10 January 2026**

Call for Papers: Special Issue of Peace Review Between Co-existence and Reconciliation: Islands of Peace in Ongoing Violent Conflicts

Rosario Figari Layus, Conrad Schetter and Esther Gardei are preparing a special issue of Peace Review. Researchers are welcome to submit contributions for a special issue that investigates local experiences of peaceful coexistence and collaborative relations emerging within contexts of ongoing violence – so-called “islands of peace.”



The issue aims to address questions such as: What factors enable the creation and endurance of these initiatives and spaces? Who are the principal actors involved, and how do they navigate the complexities of protracted conflict? What challenges do they face in sustaining and safeguarding these fragile environments of peaceful interaction? Submissions from scholars in the social sciences and humanities are welcome.

The deadline for submissions is **31 April 2026**.
